As an additional condition of obtaining, extending, amending or renewing a contract with a state agency I agree as follows:

1. Prior to entering into any agreement with any subcontractor, prior or subsequent to the contract date, I will require the subcontractor to complete a **CONFIDENTIALITY AND DISCLOSURE** form. Subcontractor shall mean any person or entity with whom I enter an agreement whereby I will be obligated to the performance of my contract with the state agency, for consideration, all, or any part, of the performance required of me under the terms of my contract with the state agency.
2. I will include the following language as a part of any agreement with a subcontractor:
